PARADE VENDOR OPERATION AGREEMENT

This Agreement is made between \_\_\_\_\_  
(hereinafter "Organization") and the Temple City Camellia Festival (TCCF) as the sole organizer and operator of the Temple City Camellia Festival:

It is understood that the Temple City Camellia Festival (Festival) is a public event organized and coordinated by TCCF. That the TCCF and the Organization wish to provide food and other items for attendees at the Parade, and agree that the goods and services to be distributed to, or for the enjoyment of, the public at the Parade should be of the highest quality possible.

Based on the above, the parties agree as follows:

1. Parade Vendor Location:

The Parade takes place on Las Tunas Drive, between Sultana and Kauffman, Temple City, California on February 24, 2024. TCCF agrees to allow the Organization to sell items as listed in Paragraph 5 below along the parade route. Organization agrees to the fees, hours, and all additional requirements as set out in the following paragraphs.

2. Amenities:

Organization will provide all supplies, equipment, and product.

3. Permits:

Organization will secure all necessary health, food, and other permits and/or licenses required by law at its own expense. Organization agrees to abide by all applicable federal, state, and City laws, statutes, codes, ordinances and regulations in effect during the term of this Agreement, as well as all relevant health and fire codes, and all trademark, copyright and other intellectual property laws.

4. Hours:

Organization is authorized to sell items throughout the parade and up to one (1) hour prior to the commencement of the parade. Scheduled parade start time from Las Tunas and Sultana is 10:00 am and lasts approximately 2 hours.

5. Parade Vendor Items:

Organization agrees to sell only those item(s) as listed below which must be approved by TCCF.

6. Parade Vendor Obligation:

Organization also agrees:

- a. To dispose of trash/waste in approved waste containers;
- b. To comply with any rules and regulations established by TCCF for Vendors;
- c. To have a responsible adult (18 years or older) present along the parade route;
- d. Loud speakers are not permitted;
- e. No raffle, solicitations, or advertisements of any type are allowed.

7. Liability:

Organization shall indemnify, defend, and hold harmless the City of Temple City and TCCF, its officers, employees, agents, and volunteers from any and all losses, costs, expenses, claims, liabilities, actions, or damages, including liability for injuries to any person or persons or damage to property arising at any time during and/or arising out of or in any way connected with Organization's authorized activities under the terms of this application and use or occupancy of the City property, facilities, and/or adjoining property, unless solely caused by the gross negligence or willful misconduct of the City of Temple City and/or TCCF, its officers, employees, agents, or volunteers.

8. Indemnification:

The Organization agrees to indemnify City of Temple City, any officer or employee of City, TCCF, and any officer or volunteer of TCCF, from any and all fees, costs, and expenses incurred by them in connection with any claim, lawsuit, or proceedings arising out of or in connection with any act or omission of the Organization or its agents in connection with the Organization's involvement with the Festival.
